Dear Friends of Learning Foundation Schools:

The Arizona tax credit program is a unique and important way for supporters of education to donate to school programs. An individual may claim a nonrefundable tax credit for making contributions or paying fees directly to a public school in Arizona for support of eligible activities, programs or purposes as defined by statute. The public-school tax credit is claimed by the individual taxpayer on Form 322.

You can divert up to \$200 (if single) or \$400 (if married and filing a joint return) of your state income tax to benefit children in their school. Current legislation allows you to contribute this money to public schools for extracurricular activities. You may then deduct 100 percent of the credit amount directly from your Arizona State income tax. Only one credit of \$200 or \$400 is allowed per tax return. Please understand that this is a tax credit, not a deduction. The credit is given against your total income tax liability and may be donated anytime during the tax year and up to April 15 of the following year .

These tax dollars may be used for school-sponsored extracurricular activities that will supplement our school programs and enhance classroom learning through activities that help students develop qualities of leadership, team play, and cooperation.
